#### Exhibitor/Speaker Reservations:

Exhibitor Booths are officially booked on a first come, first served basis once the application and terms and conditions have been submitted for review and the application approved. The categories for the Health & Wellness Expo have been predetermined and include physical, spiritual, emotional and social health and wellness. Applicants will receive presentation rights at the Health & Wellness Expo free of charge pending application approval.

#### Payment:

Payment can be made by credit card or cash. DO NOT mail cash. Please make arrangements for cash payment. Payment and promotional material for giveaway bags must be delivered to Calgary Health Trust at South Health Campus prior to July 30, 2014.

#### Subletting and Assignment:

Under no circumstances shall the exhibitor sub-license or transfer any of the allocated exhibit/booth space unless officially approved by the SHC Expo Committee. Requests must be submitted in writing and be approved 30 days prior to the Fair start date.

The Exhibitor will not exhibit nor allow to be exhibited in the allocated booth/exhibit space any products, advertising materials, services or demonstrations not relating to the original description displayed on the Exhibitor Application under

#### Disruption Policy & Agreement:

All exhibits must be manned and remain intact until the Expo closes.

#### Insurance:

The Exhibitor assumes all responsibility of retaining their own policy of Insurance. The Policy must cover the period commencing on the morning of the move-in date, ending at midnight on the move-out date, and hold a minimum coverage of \$2,000,000.00. The policy must also name the SHC Expo Committee, Calgary Health Trust and Alberta Health Services as "loss insured" and state that the Exhibitor is solely responsible and insured against all claims of any kind arising from or in any way relating to the Exhibitors presence and/or operations during residence at the show. A copy must be available on site during the show for review by the Exhibition Committee at any given time.

#### Demonstrating:

All distribution of information and demonstrating must take place in the allotted area of the booth/exhibit space allocated to the Exhibitor. If related activities are disrupting neighbouring Exhibitors of the flow of traffic, the SHC Expo Committee has the right to stop the activity. A policy of insurance may be required if demonstrating involves hands-on interaction with visitors. The Exhibitor assumes full liability and responsibility to all circumstances relating to losses, damages, personal injury or death.

#### Sampling:

All intentions to sample supplements and or pre-packaged products must be approved by the SHC Expo Committee. In some circumstances compliance is required to be approved by Alberta Health Services. The Exhibitor assumes full liability and responsibility to all circumstances relating to losses, damages, personal injury or death.

#### Termination:

The SHC Expo Committee reserves the right to terminate any contract and/or exhibit due to breach of contract, unbecoming behavior or violation by the Exhibitor/personnel registered under Exhibitor. If such termination is necessary, the SHC Expo Committee is under no obligation to refund any payments made by the Exhibitor.

#### Release and Waiver:

In consideration of the acceptance of this Application and the permission to participate in the South Health Campus Community Health & Wellness Expo, at the South Health Campus to be held September 5-6, 2014, the Exhibitor, for themselves, their heirs, executors, assigns, administrators and next of kin, assumes all responsibility/liability for theft, losses, injury, damages, and/or claims arising out of the Exhibitor's personnel, displays, equipment and other property brought upon South Health Campus' premises.
